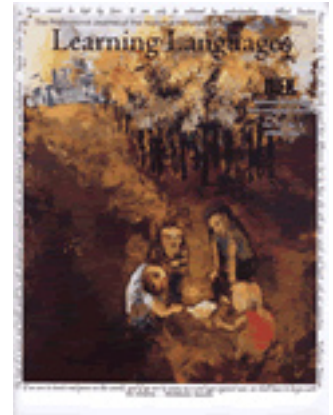


# LEARNING LANGUAGES

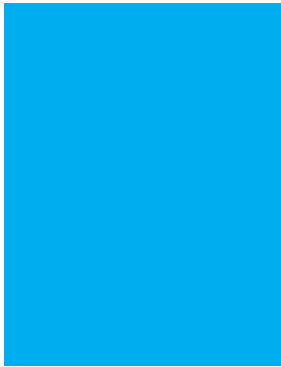
## CANCELLATION

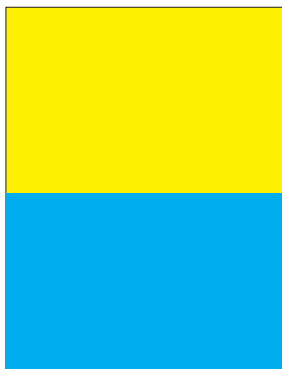

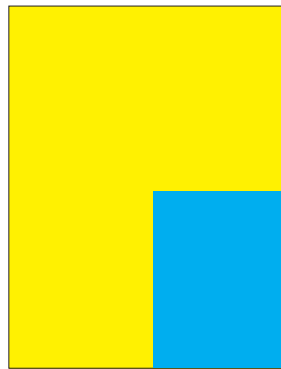
